

As Pimpri Chinchwad Municipal Corporation is a corporate body constituted under the provision of Maharashtra Municipal Corporation Act (previously known as BPMC Act, 1949) and its medical officer of health having an authority to execute contracts on behalf of the Corporation whereas the Corporation owns and is running various hospitals within its territorial jurisdiction.

AND

Whereas Late Shree Fakirbhai Pansare Education Foundation's College of Physiotherapy (BPTH) established in the year 2008 and duly recognized by Maharashtra State OTPT Council, Mumbai and it is affiliated to Maharashtra University of Health Sciences, Nashik PSO-G.R No. Maharashtra Government of approved by and 1307/PR.NO.27/07/Education-1, dated 14/09/2007 and Chairman of Late Shree Fakirbhai Pansare Education Foundation's having powers to enter into an agreement for affording practical training of students of the college of Physiotherapy (BPTH) at PCMC Hospitals Under Pimpri Chinchwad municipal corporation.

AND

Whereas the Corporation as there upon in its standing Committee Meeting passed resolution No-62 dated 06/02/2023 allowing Late Shree Fakirbhai Pansare Education Foundation college of Physiotherapy to use Yashwantrao Chavan Memorial Hospital and Pimpri Chinchwad Municipal Corporation all Hospitals for practical training for its students of Physiotherapy (BPTH)

Now therefore following terms and conditions have been prescribed for MOU and those have been accepted by both the parties:

- 1. Late Shree Fakirbhai Pansare Education Foundation college of Physiotherapy (BPTH) will pay Rs. 25,000/- as deposit (refundable) towards PCMC Hospitals of Corporation for granting permission to BPTH course.
- 2. The corporation hereby allows Late Shree Fakirbhai Pansare Education Foundation college of Physiotherapy (BPTH) to make use of PCMC Hospital i.e. (YCM, Thergaon, Akurdi & Etc.), for the practical training to its Physiotherapy (BPTH) Students.

3. IIIrd year to Internship Year-25 students

- 4. The corporation will not pay any remuneration to Late Shree Fakirbhai Pansare Education Foundation college of Physiotherapy (BPTH) students on this account.
- 5. Late Shree Fakirbhai Pansare Education Foundation college of Physiotherapy (BPTH) will not claim any type of fund or grant from the corporation for this educational activity.
- 6. In consideration for the facility of practical training made available. Late Shree Fakirbhai Pansare Education Foundation college of Physiotherapy (BPTH) will pay the remuneration to the corporation.
 - According to Government Decision No HSP-2015/Letter No-196 / SKT/Education-1 dated 12/12/2017, conhence from remuneration of Medical Education and Pharmaceutical Department.
- 8. Remuneration will be paid as per the rate prescribed by the Govt. of Maharashtra per day per bed Rs.150/- for each student training fee and there will be 10% increase in it for every year.
- 9. The clinical instructors/ clinical Tutors will do day today supervision during posting in concern hospital.
- 10. Late Shree Fakirbhai Pansare Education Foundation college of Physiotherapy (BPTH) will ensure that the students will maintain discipline during the tenure of training in the hospital.
- 11. Late Shree Fakirbhai Pansare Education Foundation college of Physiotherapy (BPTH) has to ensure that the students attending the hospital regularly and in time for the duty hours.
- 12. This agreement is valid for a period of 01st Jan 2024 to 31st Dec. 2028. the date of this agreement and renewable for every five consecutive years as per the resolution of standing committee.
- 13. Late Shree Fakirbhai Pansare Education Foundation college of Physiotherapy (BPTH) will be responsible for all the claims, correspondence or (BPTH) will be responsible

for all the claims, correspondence or expenses payable to PCMC for consequences of any accident occurred or injuries sustained by any student in the PCMC hospital.

- 14. It is agreed by & between the parties that any dispute arisen in terms of this agreement Commissioner, PCMC has the authority to terminate this agreement without any prior notice.
- 15. It is assumed that the parties have to sign this agreement on the day and year mentioned above.
